

ORDINANCE NO. 1069

AN ORDINANCE AMENDING TITLE TEN (10) CHAPTER THIRTY (30) SECTION ZERO FIFTEEN (015), TO REVISE THE POSTED SPEED LIMIT FROM A DESIGNATED THIRTY-FIVE-MILE-PER-HOUR ZONE AND DESIGNATED FORTY-MILE-PER-HOUR ZONE TO A ZONE OF THIRTY MILES PER HOUR FOR CERTAIN STREET AREAS IN FAIRFIELD, IOWA

BE IT ORDAINED AND ENACTED BY THE CITY COUNCIL OF THE CITY OF FAIRFIELD, IOWA, THAT:

Section One: Addition: Ordinance Section 10.30.015 (4) addition of the following: (4) Southbound on Main Street (IA 1) from Burlington Avenue to approximately 500 feet north of Buchanan Street” is hereby amended by the designation that street area becomes subject to the thirty-mile-per-hour (30) limit of Municipal Code Section 10.30.015.

Section Two: Addition: Ordinance Section 10.30.015(5) addition of the following: (5) Northbound on Main Street (IA 1) from approximately 500 feet north of Buchanan Avenue to Burlington Avenue” is hereby amended by the designation that street area becomes subject to the thirty-mile-per-hour (30) limit of Municipal Code Section 10.30.015.

Section Three: Severability: If any section, provision, or part of this Ordinance shall be adjudged to be invalid or unconstitutional, such adjudication shall not affect the validity of the Ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.

Section Four: Effective Date: This Ordinance shall be in full force and effect immediately after its final passage, approval and publication as provided by law.
