

ORDINANCE NO. 1076

AN ORDINANCE AMENDING TITLE TEN (10) CHAPTER THIRTY-FIVE (35) SECTION ZERO TEN (010), SECTION ZERO TWENTY (020) AND SECTION ZERO TWENTY-FIVE (025) TO REVISE THE POSTED PARKING TIME LIMITS FOR CERTAIN MUNICIPAL PARKING LOT SPACES IN FAIRFIELD, IOWA

BE IT ORDAINED AND ENACTED BY THE CITY COUNCIL OF THE CITY OF FAIRFIELD, IOWA, THAT:

Section One: Repealer. Section 10.35.010 (Time Limit) of the Fairfield Municipal Code is hereby repealed.

Section Two: Addition: Ordinance Section 10.35.010 (Time Limit) addition of the following: It is unlawful to stop, stand, park or leave immobile any vehicle, motor vehicle or chassis or body of any motor vehicle in or upon any off-street non-metered parking lot, either owned or leased by the city of Fairfield, for a longer period of time than twelve consecutive hours; except for designated long term parking spaces that are individually marked.

Section Three: Repealer. Section 10.35.020 (Limit sign posting) of the Fairfield Municipal Code is hereby repealed.

Section Four: Addition: Ordinance Section 10.35.020 (Limit sign posting) addition of the following:

All such parking lots shall have posted therein a sign designating the twelve-hour time limit. Each long term parking space shall have posted a sign designating it as long term parking.

Section Five: Addition: Ordinance Section 10.35.025 (Parking Restrictions) addition of the following:

- (1) All vehicles using parking spaces in municipally owned or leased parking lots shall follow the regulations for snow removal.
- (2) All vehicles using long term parking spaces in municipally owned or leased parking lots are prohibited from advertising said vehicle for sale.
- (3) All vehicles using long term parking spaces in municipally owned or leased parking lots must have current license and must be operational.

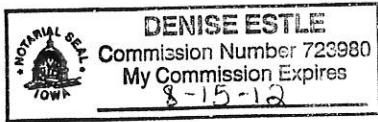
