

ORDINANCE NO. 1087

AN ORDINANCE ESTABLISHING THE GRADE OF 227th STREET PROPOSED PAVING IMPROVEMENTS CITY OF FAIRFIELD & JEFFERSON COUNTY, IOWA 2012.

BE IT ENACTED BY THE FAIRFIELD CITY COUNCIL,

SECTION 1 - ELEVATIONS. That the centerline grades of the 227th Street Paving project are hereby established about the datum plane as follows:

The centerline of the roadway at a point 924.62 feet west of the West edge of IA Hwy 1 on 227th Street is Stationing 19+51.00. Stationing to increase from West to East to Station 28+75.62.
