

ORDINANCE NO. 1126

AN ORDINANCE ESTABLISHING CODIFIED CHAPTER 10.34.095 AS NO PARKING AREAS WITHIN THE FAIRFIELD MUNICIPAL CODE TO PROHIBIT PARKING WITHIN THE CITY RIGHT OF WAY ALONG HIGHWAY ONE (1) SOUTH IN THE VICINITY OF AND APPROACHING THE HEALTH CENTER COMPLEX AND FOUR-LANE INTERCHANGE

BE IT ORDAINED BY THE CITY COUNCIL OF FAIRFIELD, IOWA:

SECTION 1. Purpose and Intent. The purpose of this Ordinance herein is to add a prohibition for parking located in the City of Fairfield Right of Way next to City Streets (Main Street/Highway One (1) where parking is not permitted.

SECTION 2. Establishing Language. Chapter 10.34.095 of the Fairfield Municipal Code is hereby established by enactment of the following language: "...No Parking on the West side of Highway One (1) from 227th Street to 218' North of Centerline of Libertyville Road and No Parking on the East side of Highway One (1) from 227th Street to centerline of Libertyville Road shall be permitted."


218 feet North of the Centerline of Libertyville Road is at mile marker 23.73 and station 330+13
Centerline of Libertyville Road is at mile marker 23.23 and station 327+95
Centerline of 227th Street is at mile marker 22.77 and station 300+76

SECTION 3. Repealer. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 4. Severability Clause. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

SECTION 5. When Effective. This ordinance shall be in effect after its final passage, approval and publication as provided by law.
