

ORDINANCE NO. 1141

**AN ORDINANCE AMENDING ORDINANCE NUMBER 645
AND SECTION 20.16.030 OF THE MUNICIPAL CODE
OF THE CITY OF FAIRFIELD, IOWA.**

BE IT ORDAINED by the City Council of the City of Fairfield, Iowa:

SECTION I. The Zoning and District Map dated March 26, 1996 and referred to in Section 20.16.030 of the Municipal Code of the City of Fairfield, Iowa, is hereby changed and amended in the following respects:


- (a) The following described territory within the corporate limits of the City of Fairfield, Iowa, is hereby changed from A-1 Agricultural District to R-2 General Residence District:

A part of Industrial Park Addition to the City of Fairfield located in the Northeast Quarter of the Northwest Quarter of Section 26, Township 72 North, Range 10 West of the Fifth Principal Meridian, Jefferson County, Iowa, being more particularly described as follows:

Beginning at the Northeast Corner of the Northwest Quarter of said Section 26; thence South 01 degrees 30 minutes 11 seconds East along the east line of said Northwest Quarter a distance of 799.83 feet to the north line of a certain parcel of land as described in Warranty Deed recorded in Book 212, Page 452 in the Jefferson County Recorder's Office; thence South 88 degrees 50 minutes 56 seconds West along said north line a distance of 163.00 feet to the east line of Parcel "B"; thence North 01 degrees 30 minutes 11 seconds West along said east line a distance of 30.00 feet to the north line of said Parcel "B"; thence South 88 degrees 50 minutes 56 seconds West along said north line a distance of 619.75 feet to the west line of said Parcel "B"; thence North 01 degrees 30 minutes 04 seconds West along the northerly extension of said west line a distance of 94.36 feet to a southerly line of Parcel "A"; thence North 88 degrees 44 minutes 13 seconds East along said southerly line a distance of 384.72 feet to a easterly line of said Parcel "A"; thence North 01 degrees 15 minutes 33 seconds West along said easterly line a distance of 434.00 feet to a northerly line of said Parcel "A"; thence South 88 degrees 44 minutes 13 seconds West along said northerly line a distance of 524.00 feet to a easterly line of said Parcel "A"; thence North 01 degrees 15 minutes 33 seconds West along said easterly line a distance of 290.00 feet to the north line of said Northeast Quarter of the Northwest Quarter; thence North 88 degrees 44 minutes 13 seconds East along said north line a distance of 918.94 feet to the Point of Beginning, containing 11.90 acres, more or less.

SECTION II. This Ordinance shall be in full force and effect after adoption and publication as required by law.

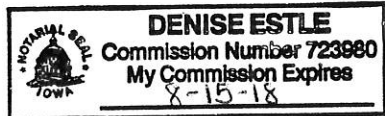
