

ORDINANCE NO. 1138

AN ORDINANCE AMENDING PART OF ORDINANCE NO. 1034, TITLE SEVENTEEN (17) CHAPTER SEVENTY-SIX (76) SECTION ONE HUNDRED (100) BY DELETION, SUBSTITUTION, AND ADDITION WITH RESPECT TO FIRST FLOOR PROJECTING SIGNS IN THE FAIRFIELD MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF FAIRFIELD, IOWA, THAT:

SECTION 1. REPEALER. Ordinance 1034 and its codification at Chapter 20.76.100 Projecting Signs, (a) First Floor, which states:

“(a) First Floor. Each first floor establishment may have one projecting sign which may not extend more than thirty-six inches from the vertical plane of the facade to which it is affixed. Such sign shall not exceed six square feet in area and shall be erected so that the lowest portion of the sign shall be not less than eight feet above the ground. Such projecting signs shall not be internally illuminated;”

IS HEREBY REPEALED.

SECTION 2. AMENDMENT. Fairfield Municipal Code Chapter 20.76.100 Projecting Signs, (a) First Floor, is thereafter **AMENDED BY SUBSTITUTING** the following:

“(a) First Floor. Each first floor establishment may have one projecting sign, here in after referred to as a “Blade Sign”, which may not exceed more than sixty inches from the vertical plane of the façade to which it is affixed. Such sign shall not exceed twelve square feet in size and shall be erected so that the lowest portion of the sign shall not be less than seven feet above ground. Such signs may contain the name of the establishment, logo or other representation of the product or service provided by the establishment, but may not contain advertising of another organization. Such projecting signs shall not be internally illuminated;”

SECTION 3. SEVERABILITY. If any section, provision, or part of this ordinance shall be adjudged to be invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provisions, or part thereof not adjudged invalid or unconstitutional.

SECTION 4. EFFECTIVE DATE. This Ordinance shall be in effect immediately after its final passage, approval and publication as provided by law.

Passed by the Council of the City of Fairfield, Iowa on the 23rd day of May, 2016.
