

ORDINANCE NO. 1166

AN ORDINANCE REPEALING ORDINANCE NO. 1056 (2010), NO. 1069 (2011), AND NO. 1075 (2011) AND AMENDING TITLE TEN (10) CHAPTER THIRTY (30) OF THE MUNICIPAL CODE OF THE CITY OF FAIRFIELD, IOWA.

BE IT ORDAINED BY THE CITY COUNCIL OF FAIRFIELD, IOWA, THAT:

SECTION 1. Repealer.

1. Ordinance 1056 (2010) and its codification at Chapter 10.30.005 is hereby repealed.
2. Ordinance 1069 (2011) and its codification at Chapter 10.30.015 is hereby repealed.
3. Ordinance 1075 (2011) and its codification at Chapter 10.30.015 is hereby repealed.
4. Section 10.30.005 (3) of the Fairfield Municipal Code is hereby repealed.
5. Section 10.30.007 of the Fairfield Municipal Code is hereby repealed.
6. Section 10.30.010 (3) of the Fairfield Municipal Code is hereby repealed.
7. Sections 10.30.015 (1) and (3) of the Fairfield Municipal Code is hereby repealed.

SECTION 2. Addition to Section 10.30.003 of the Fairfield Municipal Code "Streets with fifty-five miles per hour limit".

1. Section 10.30.003 (1) is hereby added: (1) South Main Street (Iowa Highway 1) from approximately 300 feet south of the center line of the West Bound US 34 on/off ramp to the south City Limits.

SECTION 2. Addition to Section 10.30.004 of the Fairfield Municipal Code "Streets with Fifty miles per hour limit".

1. Section 10.30.004 (1) is hereby added: (1) South Main Street (Iowa Highway 1) from approximately 250 feet south of the center line of Libertyville Road to approximately 300 feet south of the center line of the West Bound US 34 on/off ramp.

SECTION 3. Addition to Section 10.30.005 of the Fairfield Municipal Code "Streets with forty-five miles per hour limit".

1. Section 10.30.005 (3) is hereby added: (3) North Fourth Street (Iowa Highway 1) from the maximum speed sign posted at approximately 1530 feet north of the center line of Merrill Avenue to the North City Limits.
2. Section 10.30.005 (5) is hereby added: (5) South Main Street (Iowa Highway 1) from approximately 750 feet north of the center line of Libertyville Road to approximately 250 feet south of the center line of Libertyville Road.

SECTION 4. Addition to Section 10.30.007 of the Fairfield Municipal Code "Streets with forty miles per hour limit".

1. Section 10.30.007 (1) is hereby added: (1) South Main Street (Iowa Highway 1) from approximately 330 feet south of the center line of Fillmore Avenue to approximately 750 feet north of the center line of Libertyville Road.

SECTION 5. Addition to Section 10.30.010 of the Fairfield Municipal Code "Streets with thirty-five miles per hour limit".

1. Section 10.30.010 (3) is hereby added: (3) South Main Street (Iowa Highway 1) from approximately 850 feet south of the center line of Madison Avenue to approximately 330 feet south of the center line of Fillmore Avenue.

SECTION 6. Addition to Section 10.30.015 of the Fairfield Municipal Code "Streets with thirty miles per hour limit".

1. Section 10.30.015 (1) is hereby added: (1) North Second Street (Iowa Highway 1) from approximately 50 feet north of the center line of Briggs Avenue to Merrill Avenue.
2. Section 10.30.015 (3) is hereby added: (3) North Fourth Street (Iowa Highway 1) from Merrill Street to approximately 1530 feet north of the center line of Merrill Avenue.

SECTION 7. Amendment to Section 10.30.020 of the Fairfield Municipal Code "Streets with twenty miles per hour limit".

1. Section 10.30.020 (1) is hereby amended: (1) Main Street from Briggs Avenue to Burlington Avenue.

SECTION 8. SEVERABILITY. If any section, provision, or part of this ordinance shall be adjudged to be invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provisions, or part thereof not adjudged invalid or unconstitutional.

SECTION 9. EFFECTIVE DATE. This Ordinance shall be in effect immediately after its final passage, approval and publication as provided by law.
