

ORDINANCE NO. 1162

AN ORDINANCE AMENDING BLOCKING STREETS FOR CONSTRUCTION IN SECTION 11.12.030 TO THE MUNICIPAL CODE OF THE CITY OF FAIRFIELD, IOWA.

BE IT ORDAINED BY THE CITY COUNCIL OF FAIRFIELD, IOWA:

Section 1. The Fairfield Municipal Code is hereby amended to update the permitting process for the above-mentioned section.

Section 2. Purpose and Intent. It is the purpose and intent of this amendment to promote the public safety; and update the permitting process for blocking City Streets during construction; and have the fee structure for barricade rental associated with the closure; and allow blocking the sidewalk for construction.


Section 3. Amendment by Substitution. Fairfield Municipal Code Section 11.12.030 Permit to Block Street for Construction is Amended by Substituting the following: "Permit to Occupy Public Property for Construction".

Section 4. Amendment by Substitution. Fairfield Municipal Code Section 11.12.030 is Amended by Substituting the following:

- (a) Any person engaged in the erection or repair of any building or excavation of any nature, may obtain from the Planning and Zoning Department a permit to occupy a portion of the public right-of-way or public property.
- (b) If the work described in Section 11.12.030 (a) requires overnight work, obstruction of the street, obstruction of sidewalks, or obstruction of parking, traffic control shall be provided according to the most current version of the Manual on Uniform Traffic Control Devices (MUTCD).
- (c) Applicants may rent Traffic Control devices from the City of Fairfield Streets Department at the following rates:
 - a. Deposit \$50.00 per permit
 - b. Lighted A-Frame with Flashers (each) \$20 per day
 - c. Barricade with horses (each) \$10 per day
 - d. 50 feet of orange fencing with T-posts \$25 per day
 - e. Signs (each) \$5 per day
 - f. Cone (each) \$5 per day
