

ORDINANCE NO. 1219

AN ORDINANCE AMENDING CHAPTER 11.36 OF THE FAIRFIELD
MUNICIPAL CODE
(SNOW AND ICE REMOVAL – STREETS AND ALLEYS)

BE IT ORDAINED BY THE CITY COUNCIL OF FAIRFIELD, IOWA:

SECTION 1. PURPOSE AND INTENT.

It is the purpose and intent of these amendments to clarify snow removal procedures and to simplify the process of modifying the procedures by making it a policy rather than an ordinance.

SECTION 2. REPEALER AMENDMENT.

Fairfield Municipal Code Chapter 11.36 is hereby amended by repealing the section.

SECTION 3. SEVERABILITY CLAUSE. If any section, provision or part of this Ordinance shall be adjudged to be invalid or unconstitutional, such an adjudication shall not affect the validity of the Ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.


SECTION 4. EFFECTIVE DATE. This Ordinance shall be effective after its final passage, approval and publication as provided by law be in full force and effect.

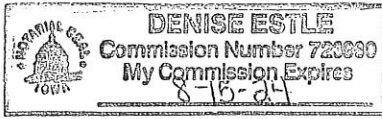
