

ORDINANCE NO. 1218

**AN ORDINANCE AMENDING CHAPTER 10.13.070 OF THE FAIRFIELD
MUNICIPAL CODE: PEDESTRIAN CROSSWALKS**

BE IT ORDAINED BY THE CITY COUNCIL OF FAIRFIELD, IOWA:

Section 1. REPEALER. Fairfield Municipal Code Section 10.13.070 is Amended by removing the following subsections:

(29) On the west and south sides of the intersection of North 4th Street and West Merrill Avenue.


Section 2. AMENDMENT BY SUBSTITUTION. Fairfield Municipal Code Section 10.13.070 is Amended by Substituting the following subsections:

(29) On the east and north sides of the intersection of North 4th Street and West Merrill Avenue and across the right turn lane on Merrill Avenue.

Section 3. SEVERABILITY CLAUSE. If any section, provision or part of this Ordinance shall be adjudged to be invalid or unconstitutional, such an adjudication shall not affect the validity of the Ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.


Section 4. EFFECTIVE DATE. This Ordinance shall be effective after its final passage, approval and publication as provided by law be in full force and effect.

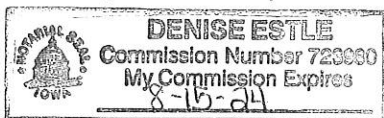
