

ORDINANCE NO. 1212

AN ORDINANCE AMENDING CHAPTER 7.04 OF THE FAIRFIELD MUNICIPAL CODE: TO PROVIDE FOR ADOPTION OF SOLID WASTE COLLECTION RATES.

BE IT ORDAINED BY THE CITY COUNCIL OF FAIRFIELD, IOWA:

Section 1. REPEALER. Section 7.04.270 of the Fairfield Municipal Code is hereby repealed.

Section 2. SUBSTITUTING AMENDMENT. Fairfield Municipal Code Chapter 7.04.270 is HEREBY AMENDED BY INSERTION of the following:

The service charge for each dwelling unit shall be established by ordinance adopted by the city council as may be required by the costs of operating the solid waste collection program. Such fee shall be eight dollars and seventy-eight cents (\$8.78) per month per household.

Annual Increase per Residential Unit shall be adjusted on July 1 in accordance to agreement for services as depicted below:


July 1, 2023	3.5%	\$9.09
July 1, 2024	3.5%	\$9.41

In addition to the service charge for each dwelling unit established by ordinance adopted by the city council, and as may be required by operation costs, the following terms and conditions are applicable:


- (1) The established monthly fee shall apply to two authorized bags or containers per household each week;
- (2) Additional solid waste bagged or contained for disposal in authorized bags or containers shall require a Waste Management sticker/tag, available for City Hall and local stores;
- (3) Cost of solid waste sticker/tag shall be one dollar each; Cost of large Item sticker is Fifteen dollars per item.

Section 3. SEVERABILITY CLAUSE. If any section, provision or part of this Ordinance shall be adjudged to be invalid or unconstitutional, such an adjudication shall not affect the validity of the Ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

Section 4. EFFECTIVE DATE. This Ordinance shall, after its final passage, approval and publication, as provided by law, be in full force and effect.
